Well, it's been a dog's age since I've written a Planning Board recap and these guys are now so well behaved I'm afraid this will be about as interesting as a 1968 trigonometry text book. Anyhow, the meeting was painless- and they seem so damn short compared to the now interminable Town Board meetings.

The only item that contained any kind of drama was the Cerlich Re-Subdivision. But that's because there was a controlled dust-up between Engineer Harry Nichols and Town Wetland Consultant, Don Cuomo. More on that later.

The most interesting item fell under new business as Mr. Camarda's Stateline project came into play. Looking back on it (and like a bad O'Henry story) it strikes me as ironically amusing. For any who missed it- this week there was an article in the PC Courier as the always debonair Mr. Lepler is in contract on the 51 acre 'Guidepost' property in Carmel. This property is almost directly behind Charming's office while Stateline is in Mr. Lepler's sandbox. Of course turn-about is always fair play and, as an added bonus, I simply adore the fact that we'll be exporting Mr. L to Carmel. Enjoy!

AGENDA:

**1. 100 Executive Drive Site Plan-** Declaration of Lead Agency, Set Public Hearing Date (6/09/08)

I got there just in time to find Mr. Lepler in the ante-room of the new Town Hall.

**2. Southeast Memorial Park Subdivision and Site Plan:** Continued Review

John Petrillo- owner. This is a two lot subdivision on North Main Street. One lot will have batting cages, the other playing fields. A zoning variance will be needed for side and front yard setbacks. There is a lot

of wetland buffer incursion. Chairman LaPerch asked who would be paying for the parking lot (when the fields were being donated to the town, the town was to pay for the lot) Surface should be pervious. Town Planner Trelsted asked how deep the soil samples had been taken. The applicant will let them know. The PB asked that Mr. Petrillo come back with a planting plan on May 12.

### **3. Joe's Barber Shop, Danbury Road**

Removed from agenda

### **4. Palumbo Kennel, South Drive- Sketch Review, SEQRA, Referral to Town Board for Special Use Permit**

Special use permit needed as applicant owns seven dogs (all Doberman Pinchers). The applicant stated that he grew up here and has moved back into town and wants to live here with his seven dogs. He said he would not be replacing them. Chairman LaPerch strongly suggested that Mr. Palumbo hire a professional to walk him through this process.

### **5. Fisher Subdivision:**

Removed from agenda.

### **6. SMSA d/b/a Verizon Wireless, 87 Hillside Avenue, Proposed co-location request for exemptions**

original tower approval took into account additions. Originally contemplated four carriers. Exemption approved. 6-0

### **7. Cerlich Re-Subdivision, Pine View Drive- Preliminary Review. Intent to Declare Lead Agency**

Proposed septic fields in wetland buffer. Wetland Consultant, Don Cuomo looked at excavated test pits which are in violation of wetland codes. Cuomo wants wetlands to be delineated to really look at implications of wetland buffer incursion. Applicant will now comply.

### **New Business:**

The Board discussed Camarda's Stateline project. The concern here is whether or not the Public comment on the DEIS should be held over the summer or held off into fall. Board member, Dennis Sullivan felt that too many residents would be away in the summer and would thus be unable to comment. Others felt that this was the largest project Southeast's seen for a while and it was imperative for the public to be able to weigh in. The general consensus was that the Public Hearings be held in fall.

### **COMMENTS/OPINIONS:**

### **100 Executive Drive:**

There was actually an impromptu presentation of this project at the Town Board meeting so I'll cover it in my Town Board recap. Suffice it to say that my encounter with the always debonair Mr. Lepler was a tad chilly in Temple Beth Dunford's depressingly stark foyer. But hey, I'll be delusional here and just chalk it up to bad karma, no heat, no light, and a jury-rigged, propped open door.

### **Southeast Memorial Park:**
