CRSE looks forward to the old landfill being capped this year. This mitigation has been on the books prior to 1995. As some of the fill has been brought in capping should be imminent. The town paid almost \$5000 in legal fees to Stephens and Charbonneau in the first 9 months of '03 for services re. the landfill such as: DEC consent orders, review of final subdivision survey, entry permits with Metro North etc. Paul Johnson is the liason.

CRSE looks forward to an updated website. We urge the website committee of Paul Johnson and Lorraine Mitts to include: e-mail addresses for all elected officials. Agendas for all boards and commissions. Minutes of all meetings to be posted not more than 3 weeks after each official meeting.
